Adviser approved continuance of nomination based appointment. After due consideration of suitability of candidate, his/her commitment to serve and recommendations received from the Society. The House gave full authority to Adviser to make such appointments in future following same procedure.

He offered to render whatever help and assistance was needed by the Society from the U.T. Administration.

ANNUAL REPORT OF THE SOCIETY 2022-2023

Dear Members,

I take this opportunity to express my sincere thanks and gratitude to all the esteemed members of the Society for their presence. I specially thank the President Shri Dharam Pal IAS, Adviser to the Administrator Chandigarh for sparing his valuable time from his busy schedule to preside over the 46th Annual General Meeting today.

The aim of the Meeting is to acquaint and inform you about the activities and the achievements of the Society during the financial year 2022-2023. Ever since the inception of the Society, 50 years back, it has been our endeavor to educate and rehabilitate visually impaired students and make them self-reliant citizens. We are getting students from Chandigarh and from neighboring states of Punjab, Haryana & Himachal Pradesh. We are able to achieve and maintain high standards in academics, sports and other fields. This could not have been possible without the support of Chandigarh Administration, Education Department, Directorate of Social Welfare, Members of the Society and the support of the general public. Now I would go over salient activities and achievements of the Society during the academic year i.e. 2022-2023.

ACHIEVEMENTS OF SOCIETY

COMPUTER LITERACY TRAINING

Computer Training being subject of study, is a very important part of our curriculum. The Society provides computer literacy since 2002 having two computer labs equipped with latest computers with screen reading softwares to teach visually challenged children from class 3rd onwards. This training is extended upto Senior Secondary Level by qualified and trained computer instructors.

BRAILLE PRESS & AUDIBLE ACCESSIBILITY OF BOOKS

Reading and writing are two most vital aspects of education, the Society made a humble beginning in the year 1997 by introducing Computerized Index Braille Embosser. It producing Braille literature in variety of languages viz. English, Hindi and Punjabi. A Production Braille Press was added in the year 2007. The Society recently introduced software in this press to transcribe the Hindi books into audio format also.

HEALTH CARE FACILITY/ EYE CHECKUP & SCREENING CAMP

Health care facility is provided to the students by a team of doctors from Sector: 16, Chandigarh and by Dr. Savita Gulati who visits the Institute twice a week. The Society also has services of trained Nurse-cum-Pharmacist to look after the day-to-day ailments of students. The students needing further medical help are taken to GMCH-32 & Govt. Hospital Sector 16. Eye camps at periodic intervals are also held in slums and rural areas in collaboration with Director Health Services UT., doctors from GMCH-32.

GYMNASIUM AND MOBILITY TRAINING

Two Gymnasiums have been setup separately for boys and girls to keep them physically fit under the supervision of qualified instructor. Mobility also plays an important and crucial role in the life of a visually impaired person. To overcome the difficulties of gait and posture, mobility training is imparted to the students. Yoga has recently been added to their physical training.

BRAILLE LIBRARY

A well-stocked library exists in the Institute. It contains material both in Braille and in Ink-Print books and magazines. We have engaged a trained Librarian to look after it.

REHABILITATION / PLACEMENT

After the completion of studies, Society makes every effort to rehabilitate the students. Even a nominee of the Society accompanies the prospective candidates to the places of interview/tests. More than 200 Ex-Students have been absorbed in Govt. and Semi-Govt. jobs with attractive salaries making them self-reliant, independent and honorable members of their families and society in general.

LIAISON / CONNECTION WITH DONORS, LIFE & PATRON MEMBERS

The Society maintains a good liaision with all the major donors, Patron and Life Members so as to ensure the adequate liaison.

ACADEMIC ACHIEVEMENTS 2022-2023

ACTIVITIES DURING ACADEMIC SESSION

(a) Union Bank organized a function on **WORLD DISABILITY DAY**, in which our Students highlighted the significance of the Day. (b) Under **SWACHHATA ABHIYAN**, Institute received certificate of accreditation under GOLD category from Department of Community Medicines & school of Public Health, PGIMER, Chandigarh. It reflects that we all are pro-active in the inculcation of cleanliness habit among our students. (c) On **VOTERS AWARENESS DAY** eligible students were enrolled and were also made aware to cast the votes properly by selecting the right candidates.

GOLDEN JUBILEE CELEBRATIONS

On the 50th Anniversary of the Society, a cultural programme was organized in Tagore Theatre on 30th November 2022 in which His Excellency Governor of Punjab and Administrator UT, Chandigarh was the Chief Guest. Students presented colorful programme which was highly appreciated by audience. The Hon'ble Governor announced grant of Rs. 19 lacs to purchase Orbit Readers for students to enhance their ICT skills.

ALUMNI MEET: As part of Golden Jubilee celebrations Alumni Meet was held on 13-11-2022. It was attended by about 125 alumni with their spouses. Besides holding an entertainment programme, they shared their experiences with our students and gave them useful tips and advice. It would work as a great incentive for the students. We now have also updated our database for our alumni. The alumni also announced scholarships to award meritorious students.

Dr. Navneet Kaur, Chairperson of National Human Rights Social Justice Council honored Col J S Bedi Vice-President, Shri B D Sharma Secretary and Principal Shri J S Jayara on behalf of Indian Society for Blood Transfusion and Immunohematology. She also presented a shield on behalf of National Human Rights Social Justice Council to the Society which was received by the Vice-President.

- On 15th July, 2022 **BLOOD DONATION CAMP** was organized in collaboration with HDFC Bank and Homeopathic Medical College, Sector-26, Chandigarh. It has raised awareness among students.

- EYE DONATION AWARENESS PROGRAMME was organized on 7.09.2022 at GMCH, Chandigarh and our students presented programme to promote cause of eye donation.
- **BLIND WALK** was organized at Sector-17, Chandigarh by National Highway Team on 14.10.2022 in order to create general awareness among public to understand gravity of disability. A team from our Institute participated it.
- On 9.02.20223 FAREWELL PARTY was given to class 12th students. Programme was attended by members of the school management including Chairman, Secretary and staff.
- I-Pads were provided to class 12th students to enable them to increase their learning skills.
- On 15.07.2022 RBI organized **CURRENCY TESTING EXERCISE** for visually impaired students. Students interacted with their staff and suggested points to make notes/currency disabled friendly.
- 22nd NATIONAL ATHLETIC CHAMPIONSHIP-2022 was held in Delhi in which nine students participated successfully. They bagged 29 Medals alongwith three championship trophies. Indeed it is a remarkable achievement for our Institute. A Press Conference was organized by the Vice-President to publicise achievements of our Institute in sports field.

ACTIVITIES RELATED TO ENVIRONMENT / SCIENCE AND TECHNOLOGY:

To enhance the knowledge of students on different aspects the Institute organized different activities as follows:

(a) Celebration of Earth Day was by organizing Quiz competition (b) Bio-Diversity talk by Shri Ivninder Pal Singh renowned Journalist (c) Declamation Contest regarding World Population Day (d) Planting of trees by Chief Conservator of forests (e) Quiz Competition regarding the protecting of Ozone Layer (f) Under the caption of wild life week visit of students to zoo (g) visit of students to Botanical Garden to have direct exposure and understanding about different plants and their significance in human life (i) Shri Paramjit Singh PGT Physics delivered informative talk on Energy to mark the energy day (j) On the occasion of National Science Day, Quiz Competition was conducted to mark the occasion.

NATIONAL FESTIVALS: On the eve of Independence Day students presented mesmerizing patriotic dance at Tagore Theatre. Adviser to the Administrator was the Chief Guest. The Chairman of the Institute and other functionaries hoisted the National Flag in the premises of the institute. Students sang patriotic songs and Mrs. Kanwaljit

INTRODUCTION OF NUTRITIOUS FOOD: To ensure that there is more variety and nutritious food served to our students, we have drawn out a menu with the help of a Nutritionist from Home Science College Sector 10 Chandigarh. We have also trained our cooks in preparation of the same. Students are very happy with this change.

WORKSHOPS

- Raised Line Foundation (RLF) organized workshop at our institute in May 2022 to create awareness regarding Tactile Diagram Books and use of mathematical Kits etc. concerned subject teachers showed interest and discussed further the way and means to make abstract ideas more accessible for visually impaired

Principal J S Jayara also attended the conference and brought certain points to her notice pertaining to welfare of women and persons with disabilities. Throughout the year the Institute received many dignitaries, scholars, students and trainees from different schools, colleges and universities to get themselves acquainted with the functioning of the institute/society and they interact with the visually impaired students. Agenda Item-V Amendment in the existing constitution

There is a need for amendment to the existing constitution for the election of functionaries and their eligibility criteria like; 1) Education qualification and experience 2) Age Preference 3) Tenure 4) Family representation. It is important for Society to follow its constitution and hold regular elections as mandated. If no elections are held due to unforeseen circumstances, one year extension can be given to office bearers by the Annual General House Meeting. The President may be empowered to appoint office bearers in case of any mis-happening during the tenure of her/his services. From henceforth below amendments in existing constitution has been taken place:

Agenda Item-VI Election of Office bearers for FY 2023-24.

As per the constitution of the Society, the election is to be held every year for the posts of office bearers. However no election has been held since its inception. The committee has proposed to conduct election amongst the Life Members and Patrons for the Office Bearer i.e. (1) Senior Vice-President, (2) Vice-President (3) Secretary (4) Joint Secretary through open advertisement/requisite procedure. To approve procedure for election of office bearers as per the constitution of Society for the year 2023-2024, preferably from amongst the patrons/life members.

To ensure a fair and transparent election process, the committee has proposed certain eligibility criteria for the candidates. These criteria are as follows:

- <u>EDUCATIONAL QUALIFICATION AND EXPERIENCE</u>: To ensure that the elected office bearers are well-qualified, experienced and committed to social services hence the candidates must be atleast graduates and should have a minimum of 10 years of experience in social service.
- 2. <u>AGE PREFERENCE</u>: The applicants should ideally be between 40 and 75 years of age.

- 3. <u>TENURE</u>: The tenure for office bearers would be three years.
- 4. <u>FAMILY REPRESENTATION</u>: To promote diversity and prevent concentration of power within a single family or household, only one member from the family would be eligible for becoming office bearer of any management committee.
- 5. The applicant can apply for single post of office bearer.
- 6. He/She should have no criminal record.
- 7. <u>NATIONALITY:</u> The member should be citizen of India.
- 8. <u>ELECTION</u> will be held after every three years for the honorary posts of office bearers.
- The entire Election process will be held under the supervision of the official of <u>THE</u> <u>REGISTRAR COOPERATIVE SOCIETIES</u>, Chandigarh Administration as per Annex – 'X' below.

It is important for the Society to follow its constitution and hold regular elections as mandated. Implementing the proposed procedure and eligibility criteria would help ensure a fair and democratic selection of office bearers.
