The above approval is subject to the following terms & conditions :-


1. The management of an aided school shall give to the Head of the School full freedom and authority for the academic work and internal administration including school discipline. No member of the staff of the school other than the Principal/Headmaster shall function as such.
2. The tenure of the Governing Body shall not exceed three years from the date of issue of this order;
3. No office bearer(s) shall be replaced without the prior approval of Director School Education, UT, Chandigarh;
4. The Nominee of Director School Education, UT, Chandigarh shall be invited in every meeting of the Governing Body without which any decision taken by the Governing Body will not be considered valid by the Director School Education, UT, Chandigarh;
5. All Instructions/regulations issued by Education Department, UT, Chandigarh shall be followed in this regard;
6. All selection of staffs (Teaching as well as Non-Teaching will be done by the duly constituted Selection Committee(s) in this regard from time to time;
7. A copy of proceedings of every meeting of Governing Body shall be sent to DEO/DSE, UT, Chandigarh.
8. A copy of aims & objects of the Governing Body shall also be supplied within one month's time to the DEO/DSE, UT, Chandigarh.
